Bradwell Waterside - Slipway Pass Regulations and Conditions

Regulations

The regulations which govern the slipway pass are as follows:-

- (1) Boats using the slipway must be covered by at least third party insurance.
- (2) Care must be taken at all times to avoid causing congestion on the slipway, and **under no-circumstances may vehicles or boat trailers be parked on the slipway, hard or dinghy park.**
- (3) Only you may use the pass and any change of vessel should be notified to me as soon as possible, as the pass can only be used for the craft specified thereon.
- (4) There is a speed limit of 4 knots in Bradwell Creek.

Conditions

The right to use the Slipway is valid until 31 March 2019 or for the date specified for a single use pass.

- 2 No vehicle, boat, trailer, or other equipment may be parked, placed or allowed to remain on the slipway or hard. In the event of a breach of this condition the County Council's servant or agent may remove any such vehicle, boat, trailer or equipment. Whilst so engaged, such person shall be the servant or agent of the holder of this pass and the County Council shall not be responsible for anything that may result or occur or for the safety of such a vehicle, boat, trailer or equipment.
- 3 The County Council reserve the right to refuse access through the barrier at any time in the interests of safety or on other reasonable grounds.
- 4 The County Council shall not be liable for any loss, injury or damage to any vehicle, boat, trailer or equipment or to any person entering upon their property, howsoever caused.
- 5 The licensee acknowledges that should Her Majesty, Customs and Excise, require the County Council to divulge to them the names and addresses of the Licensee for the better performance of their statutory duties the County Council shall be at liberty to do so without reference to the licensee.
